

GARDEN ROOM & PARSKAMER FUNCTIONS & EVENTS

Private or semi-private celebrations may be hosted in one of two function areas at the restaurant.

Celebrations with a personal touch where seasonal wholesome cuisine is served that celebrates authentic South African heritage and warm hospitality.



The Garden Room

A private indoor venue situated in a small building in the garden of the restaurant.

The Garden Room can seat up to 32 guests at two large tables (1 x 16/18 seater & 1 x 12/14 seater).

A set-menu is compulsory in the Garden Room and may be selected from a range of seasonal set-menus that can be viewed and downloaded online on our website at: <https://evertopstal.co.za/home/functions>.

The room may be booked for the following timeslots:

- Breakfast sitting from 08:00 to 11:30
- Lunch sitting from 12:30 to 16:00

No venue-fee is levied for groups of 20 or more guests. Should the booking be confirmed for less than 20 guests or should the numbers be amended to less than 20 guests the venue fee of R1750 per sitting will be applicable and added to the final bill.



The Parskamer

A semi-private room in the restaurant that is adjacent to the main inside seating area.

The Parskamer can seat up to 40 guests at two or three tables (1 x 16 seater & 2 x 12 seater) please note: unfortunately the tables cannot be joined together.

No venue fee is levied for the use of the room if 26 or more guests are confirmed and both large tables are occupied (14+12).

If the entire room is required exclusively with less than 26 guests a venue fee of R1250 will be applicable and added to the final bill.

The room may be booked for the following timeslots:

- Breakfast sitting from 08:00 to 11:30
- Lunch sitting from 12:30 to 16:00

Menu Options, Drinks & Fees

A set-menu is compulsory for bookings of more than 16 guests.

Set Menus are seasonal & amended accordingly:

Winter (valid from 1 June – 30 September)

Summer (valid from 1 October – 31 May)

The restaurant is fully licenced and serves a wide range of non-alcoholic drinks, alcoholic beverages and local wines.

Corkage @ R 50 per 750ml bottle for Wine and Sparkling wine only.

Bar tabs tailored to your preferences with either Account Bar (within agreed limits) or a Cash Bar.

A deposit is required in order to confirm a group booking which is deducted from the final bill on the day of the booking.

A service fee of 12% is added to the final bill for groups of 10 or more guests.

Final confirmation of the number of guests, the set-menu and all relevant details is required at least 10 days in advance and the bill is prepared in accordance with final confirmation regardless of any cancellations after the cut-off date and/or no-shows on the day.

Terms & Conditions of Service

GROUP BOOKINGS & DEPOSITS

1. To secure a group booking for 10 or more guests a deposit of R750 is required which will be deducted from the final bill.
2. Payment of the required deposit will be deemed as acceptance of the Terms of Service as described herein (note point 31).
3. Deposits (note points 2, 11, 18.) to be paid by means of a PayFast link (supplied on booking) or with Electronic Funds Transfer (EFT) into the following deposit bank account once booking is made:

MENUS & NUMBER OF GUESTS

4. Groups larger than 16 guests are required to select a suitable set menu option from the available function menu options (see www.evertopstal.co.za/menus).
5. The final number of guests are to be confirmed at least 10 days in advance or as agreed.
6. The confirmed number of guests will be invoiced regardless of no-shows/cancellations on the day or changes after final confirmation was received.
7. All prices include VAT and are subject to change without prior notification.
8. No outside/own catering is permitted as EVERT Restaurant exclusively provides all catering & bar services except for Halaal or Kosher meals that may be arranged with us from certified suppliers for which a surcharge will be applicable and added to the bill.
9. The supply of own cake and cupcakes are permitted and a cake fee of R20pp will be levied and added to the bill.

DÉCOR, FLOWERS, AREAS & SERVICE FEES

10. Group bookings (including Baby- & Bridal Showers) are only booked for either a breakfast slot (08:00 – 11:30) or a lunch slot (12:30 – 16:00) and for a maximum of 3 hours within the selected timeslot and only one the following areas are available:
 1. The Garden Room (private facility): maximum of 30 guests around 2 tables. No venue fee for 20+ guests, if less than 20 guests a venue fee of R1750 is applicable and added to bill. A set-menu is compulsory in the Garden Room regardless of the number of guests.
 2. The Parskamer (semi-private facility): maximum of 40 guests around 2-3 tables with. No venue fee for 26+ guests, if less than 26 guests and exclusive use is required a venue fee of R1250 is applicable & added to bill (note point 4).
 3. The Stoep (semi-private facility): maximum of 36 guests around 3 tables. No venue fee for 36+ guests, if less than 36 guests and exclusive use is required a venue fee of R1250 is applicable & added to bill (note point 4).
11. A service fee of 12% will be added to the final bill(s) for groups of 12 or more guests prior to the deduction of the booking deposit.

SET-UP, TIME & DECOR

12. Set up for group bookings to commence 30 minutes prior to booking arrival time.
13. No area is available onsite for storage/ set-up and the arrangement of flowers & decor.

14. No permanent fixtures, cables, prestik, double-sided tape, thumbtacks, nails, screws or other items that might damage walls, furniture or structures are permitted.
15. Strictly no paper confetti, feathers, polystyrene confetti, tinsel/tinsel confetti, streamers, seeds, butterflies or balloons that contain any of these items are permitted.
16. No sky lanterns or fireworks are permitted.
17. Candles are only permitted with prior approval and required to be in candles holders.
18. The deposit will be withheld in lieu of cleaning costs in the event of the use of unauthorised materials as described in points 14-17 above (note point 14).
19. Own floral arrangements & décor permitted in line with points 9-16 OR may be arranged/ordered from Evert Restaurant (note point 13).
20. Maximum of 2.5 hours (180 minutes) per booking (or as agreed in writing). Guests are requested to ensure that all activities are completed within this timeframe for strike-down, cleaning & set-up.
21. The deposit will be withheld should the agreed booking times be exceeded resulting in the delay of set-up and an any inconvenience to the next booking in the same area.

CANCELLATION & POSTPONEMENT

22. If required EVERT Restaurant will reasonably consider a postponement to another available/suitable date, provided that the alternative date is within 6 months of the original date and the deposit will be transferred to the new date.
23. Cancellation within 14days from the date of booking will result in a cancellation fee of R750.

LIQUOR & LICENCING

24. EVERT Restaurant is fully licenced for on-consumption liquor only. No alcohol will be permitted to be removed from the premises in line with the On-Consumption Liquor Licence stipulations and regulations in the liquor act.
25. B.Y.O. (bring-your-own) is allowed with a Corkage Fee of R50 per 750ml bottle. Only wine and sparkling wine is permitted, and no other drink items will be considered.
26. In line with legislation NO alcohol will be served to any person under the age of 18 and the right is reserved to request proof of identification.

ENTERTAINMENT AND MUSIC

27. All music and entertainment for events is subject to the written approval by EVERT Restaurant.
28. All equipment required for music, sound and entertainment (PA systems, projectors, TV's, extension cables, multiplugs, sound equipment, cabling etc) remains the responsibility of the client and are not provided by EVERT Restaurant.
29. Management reserves the right to control and limit sound and music levels due to the proximity of adjacent residential properties.

PREMISES

30. The building and the premises is located in a residential neighbourhood and guests are expected to respect the heritage buildings, the gardens and surrounds and are expected to act accordingly. See points 27, 29 and 34.
31. All facilities and areas at EVERT Restaurant are strictly non-smoking.
32. The EVERT Restaurant premises are monitored by a 24-hour CCTV surveillance system.
33. RIGHT OF ADMISSION on the premises of EVERT Restaurant is reserved.

AGREEMENT & ACKNOWLEDGEMENT OF T&C's

34. Payment and receipt of the required deposit will be deemed as acceptance & acknowledgement of the Terms & Conditions of Service as described herein & as displayed on www.evertopstal.co.za.
